Move out of vehicles is based on where your vehicle is stored (see below). The Agricultural society cannot guarantee move out on demand as it is dependent on the vehicle in front being moved out first.

8:30am-7:30 pm Friday April 28, 2017

Motorhomes, Large Boats & small cars

(In back half of Barns)

8 am-12 pm Saturday April 29, 2017

CONDITIONS:

- Storage will be for a 6 month period commencing October 27, 2016 and ending April 28, 2016
- Cost of storage will be \$12.00 per linear foot multiplied by the length of the vehicle plus 13% HST. An additional linear foot will be added to the total length of vehicles for storage in calculating total cost for vehicle storage for the 6 month period. The length of vehicle is to be measured and recorded by Woodstock Agricultural Society staff prior to entry into storage facility. There is no refund for early removal. **Full payment is due prior to entry. Cash, debit, credit or cheque (Payable to the Woodstock Agricultural Society) accepted.**
- Batteries shall be disconnected or protected from sparking. **Propane tanks shall be removed from the vehicle when stored. Fire regulations do not allow propane tanks to be stored indoors.**
- a) The undersigned customer has viewed the storage facilities of the Woodstock Agricultural Society and accepts those storage facilities in the state they are in at the time of storage. The customer further agrees that it fully releases and discharges the Woodstock Agricultural Society from any responsibility whatsoever for any loss or damage, however caused to their stored property upon signing this agreement. Further, the customer agrees to indemnify and save harmless the Woodstock Agricultural Society from any claims for loss or damage to Woodstock Agricultural Society property or any other property stored therein however caused, by acts or omissions of the customer.
- b) That all customers shall carry adequate insurance covering normal occurrences including, but not limited to, Fire, Wind, Water, Theft, Vandalism and Public Liability Insurance related to their particular vehicles and **provide satisfactory evidence** to the Woodstock Agricultural Society of said insurance.
- c) The customer acknowledges that this complete waiver of claim against the Woodstock Agricultural Society and the indemnification to the Woodstock Agricultural Society and an integral part of this storage agreement and the Woodstock Agricultural Society would not have allowed the customer's property to be stored in facilities owned by the Woodstock Agricultural Society without the customer's agreement to these terms.
